

The Grand Haven Municipal Marina is operated under the Code of Ordinance of the City of Grand Haven, Section 18. It is up to the boat owner and their guests to be familiar with and abide by ALL local, state and federal requirements related to Michigan's Waterways and the Municipal Marina. This is not a complete list of the rules and regulations. Please refer to Section 18 of the Code of Ordinance.

1. No slip may be occupied without a permit obtained from and issued by the Marina.

Sec. 18-96 Unauthorized Berthing

No vessel shall occupy any marina slip without authorization/permit by the operator. Unauthorized vessels berthed at the marina shall be considered trespassing and may be removed and impounded by the operator. All costs associated with the removal and retrieval of the unauthorized vessel shall be the responsibility of the vessel owner. The owner of the vessel shall also be subject to the Violations section of the ordinance contained at Section 18-95 herein.

2. Check out time at the Marina is 12:00 noon. Any boat which remains will in the slip beyond the check-out time must pay the fee for an additional day.
3. No tenant shall be allowed to stay at the Marina for more than 7 consecutive days.
4. No tenant shall leave a boat in the Marina and leave the City of Grand Haven for longer than a 24 hour period. This is a transient marina, not an interim storage area.
5. NO swimming, diving or fishing is permitted in the Marina.
6. Tenants MAY NOT store accessories, supplies, beach chairs, stairs, dock boxes, materials or debris on any walkway, dock or Marina grounds.
7. NO grilling is allowed on any dock, walkway or Marina grounds. Designated grilling areas are available for tenants use.
8. Disorderly conduct by a tenant or his guests which might cause injury to a person, damage to a property or otherwise cause a nuisance shall be cause for immediate eviction from the Marina. No refunds shall be made.
9. NO consumption of alcohol in public places is allowed. This is a violation of Sec.5-12 of the Grand Haven Code of Ordinance. Open containers are only allowed on docks and boats. Tenants may not walk between docks or sit in parklands or picnic tables with open containers.
10. Cleaning of fish and discarding remains shall only be done at the Fish Cleaning Station. Contact marina staff for entrance during designated times.
11. Overnight seawall mooring is \$30 (\$60 during 4th of July & Coast Guard). Complete registration and pay at Marina office.
