Aviation activity and fuel sales were up in January.

Flight school is busier.

23 people on hangar waiting list.

Apron and taxiway painting in the spring. MDOT to review crack sealing in the spring.

Snowplow has peeled crack seal in many places.

Tree trimming: South approach- Earle presented trees on South approach that are conflicting with the clearway. Rick suggested a survey prior to taking these trees out.

We have \$9000 in the budget to use on tree care. Tree encroachment is keeping us a basic utility airport instead of a general utility airport.

We have sold 469 gallons of fuel.

No noise complaints.

Several hangar doors replaced on tracks.

East end windsock blew over again. Repaired.

No mechanic yet. A&P's and IA's coming in and it looks good with regard to finding one.
