#### **Old Business:**

Preparation of land lease presentation for city council:

Decisions from board work session on 7/11/24:

- Private built hangars shall meet all the minimum requirements of the FAA, MDOT Aero, and the city of Grand Haven.
- Minimum hangar size will be 60'Length x 60' Depth, with minimum ceiling height of 16', and minimum opening of 60' Wide x 16' Height
- Single phase electric, metered separately
- Interior floor shall be concrete.
- Apron shall be 60'x60', and shall be concrete or asphalt
- Min. lot size shall be 80' Wide x 130' Depth; 10,400 sq. ft. total

• Leased terms shall be 10 years with two additional terms of 10 years, or a single 30 year contract.

These are minimums, yet all proposed structure will require board approval.

We are looking at \$.35 per sq. ft. per yr. This would amount to approximately \$3640 going to the airport funds within the city.

Denny- We should give top three reasons why city council should approve this.

Activity and fuel sales are behind from previous years.

Surveyors to come shortly and borings of runway have been taken.

## **Projects**

Design stage of N/S runway has begun and is under contract. Surveying should be completed this month.

Construction of new hangars: Planning on tear down of "C" row. Build of T-hangars pending our review and decision.

Stump grinding applied to fiscal year 2023.

No deer reports or wildlife reports.

Summer airport maintenance items underway.

MDOT Aero agrees with our opinion to move forward with runway rehabilitation before taxiway rehab. We need to add the taxiway rehabilitation to our capital improvement plan.

Additional money may be available to use on building hangars.

## Fuel sales, Operations, Activity

- Fuel sales are going down for this time of year
- Fuel prices going up and down recently, 100LL climbing, Jet A remains steady.
- Flight instruction slow, 1 flight instructor.

No noise complaints. Earle has received no wildlife complaints.
