The Special Meeting of the Grand Haven City Council was called to order at 7:00 p.m. by Mayor Cathy McNally in the City Council Chambers located in Grand Haven City Hall, 519 Washington Ave.

APPROVAL OF THE AGENDA

22-039 Motion by Council Member Cummins, seconded by Council Member Fritz to approve the agenda as presented. This Motion carried unanimously.

CALL TO THE AUDIENCE

Five members of the public provided public comment:

1. Mike Smith 113 N. 2nd St., Grand Haven Coast Guard Festival, spoke about the special event fees paid by the Coast Guard Festival and expressed concerns that the overall cost incurred by organizations would be problematic if a fee increase is adopted. Smith estimated that holding the festival with the price structure in the proposed updates would result in fees of over \$56,000 for the Coast Guard Festival.
2. Ted Raggl, 20 N. 1st St., VFW Post 2326, spoke about the services and activities the VFW provides to the community and the ways in which proceeds from Rib Fest benefit local veterans.
3. Mike Baauw, 20 N. 1st St., VFW Post 2326, spoke in support of the events the VFW holds and the impact the proceeds from the events have on the community.
4. Al Schmidt, 20 N. 1st St., VFW Post 2326, shared information about support services provided to veterans in the area provided by VFW Post 2326.
5. Daniel Bowers, 18 Washington Ave., Long Road Distillers, spoke on behalf of Long Road Distillers in support of the outdoor dining proposal on Washington Ave.

Housing Next Updates

Ryan Kilpatrick, Executive Director, Ottawa County Housing Next have a presentation to provide an overview of Housing Next activities which included:


- Specific projects in the City of Grand Haven and Holland Township.
- A comparison of the rental housing needs assessment between 2018 and 2021 for the region.
- A comparison of for-sale housing needs between 2018-2022 and 2021-2025 for the region.
 - Both comparisons utilize many data points, including Census Data, credit card data, economic development data, macro-trends, job creation, age and condition of housing stock.
- Construction prices for various types of housing developments (single family, multifamily, etc.)
- Advocacy for a combination of public policy and philanthropy.


CM Lowe asked for information about where jobs were being created in the region. No response was provided during the work session.
