Community Members present: Bob Monetza, Mayor of Grand Haven.

Others Present: Fifteen Individuals from the community were present including members of the St. John's Immigrant Justice Team.

- 1. Upon the presentation of the Agenda, Comm. Mendiola-Suarez motioned to approve said agenda with Comm. Termolen seconding the motion.
- 2. Upon the presentation of the February meeting Minutes, Comm. Termolen motioned to approve said Termolen meeting minutes with Comm. Mendiola-Suarez seconding the motion
- 3. A welcome call to the audience is made by Comm. Brown. Monetza stated the Grand Haven City Council did issue a statement regarding its noninvolvement in idea of Grand Haven becoming a Sanctuary City. Mayor Monetza stated that the DEI Proclamation was not re-affirmed at March 2025 meeting by the Grand Haven City Council. Mayor Monetza stated a DEI statement remains listed on the Grand Haven City's website. Oliver Shampine read a passage as well as gave his support for the Grand Haven Public Safety to issue a statement regarding how they would manage ICE involvement. Diasy Martinez spoke about undocumented individuals as well as her personal experience being a Latina woman in the Grand Haven community. Abbey Teasley wrote a personal letter regarding her immigration journey, family deportation, and information on local undocumented individuals/migrant workers read by Daisy Martinez. Mary Worbus spoke regarding being a fifth generation Grand Haven

Daisy Martinez. Mary Worbus spoke regarding being a fifth generation Grand Haven resident with family ties stemming from the Netherlands. She referenced the Old Testaments take on immigrants and, she also gave support for the Grand Haven Department of Public Safety issuing a statement regarding how they would manage ICE involvement.

b. Immigrant Justice Team Presentation. - g. A new liaison list is to be created due to lack of responses.
- h. Comm. Brown to speak with the Grand Haven City Manager regarding asking the Grand Haven Chief of Public Safety if she could attend the next HRC meeting. The HRC would like to discuss the possibility of the Grand Haven Department of Public safety issuing a statement regarding how they would manage involvement with ICE as well as undocumented individuals.
