# Water/Sewer Permit Information (Please read and initial)

1. Applicant to receive application and fee schedule at the Department of Public Works, R.V. Terrill Building, 1120 Jackson Street, Grand Haven, Michigan or at City Hall, 519 Washington Street, Grand Haven, Michigan.

# 2. Applicant must pull a permit with City of Grand Haven's Building Department if working on private property. A copy of that permit must be attached.

- 3. Application to be filled out by applicant and filed with the Department of Public Works at the R.V. Terrill Building, 1120 Jackson Street, Grand Haven, Michigan. (*This is not a mailing address*). <u>Mailing address</u>: <u>City of Grand Haven DPW, 519 Washington Avenue, Grand Haven, MI 49417.</u>
- 4. A drawing <u>MUST</u> accompany this permit of work to be completed.
- 5. The Department of Public Works will determine cost of the water or sewer tap fee. The applicant will be notified when the permit is ready to be picked up and the cost for the permit.
- 6. Sewer lines will be required to have a minimum grade of 1/8 inch per foot. A pressure test of 5 pounds of air for 10 minutes or a pressure test of a 10 foot head of water for 10 minutes using the same size pipe as the sewer line is required. Also, each end of the line will have to be inspected. The inspections are to be done by the Public Works Department. The pressure test and inspection must be <u>PRIOR TO</u> <u>BACK-FILLING OF THE SEWER LINE</u>. Only clean sand fill shall be used for backfill, compacted to a minimum of 95% density.
- 7. The contractor and/or subcontractor is to **notify Director of Public Works 72 hours in advance of mobilization**, unless it's deemed an emergency. In the case of an emergency approval, the contractor and/ subcontractor, along with the Crew Leader, will meet on site to determine if emergency approval is necessary.
- 8. When working in the City right of way, a permit is required. When a street opening is required the contractor will be responsible to restore the excavation up to grade with aggregate per specifications of the ROW permit. **The City of Grand Haven will restore HMA surface and bill the contractor.**
- 9. The contractor will be charged an additional inspection fee for each return trip to the site.
- 10. The contractor has <u>30 days</u> from start date to complete project. After such time, this permit shall be null and void.
